

## NOTICE OF RACE

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

### 1 RULES

- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing (RRS)* .  
The Prescriptions of the RNWA can be found at

- 1.2 Racing rule 44.1 will be changed .as follows: see NOR 14. The sailing instructions may change other rules as well.
- 1.3 Every person on board who has its domicile in the Netherlands shall have the appropriate license. The licenses can be checked at registration.
- 1.4 All competitors and support persons must adhere to the corona rules of the Dutch government. For the rules see <https://www.government.nl/topics/coronavirus-covid-19>
- 1.5 If there is a conflict between languages the text in the English language will take precedence.

### 2 SAILING INSTRUCTIONS

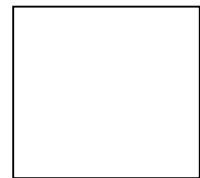

### 3 COMMUNICATION

- 3.2 [DP] From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

### 4\* ELIGIBILITY AND ENTRY

- 4.1 The event is open to all boats of the Pion, Dyas, Etchells, H Boot and Monas classes.



- 4.2 Eligible boats shall only enter by completing the entry procedure before 29th of September 0:00 at <https://wsvhoorn.nl/keel-boat-event>
- 4.3 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.
- 4.4 Competitors that have entered after 28<sup>th</sup> September 23:59 shall only be accepted after written approval of the OA and only for classes that have not reached their maximum number of allowed entries. Late entries will be accepted under the following conditions: extra fee of Eur 50
- 4.5 There is no restriction on the number of boats.

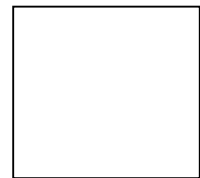

- 14.1 RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

- 15.1 (a) When fewer than 5 races have been completed, a boat's series score will be the total of her race scores  
(b) When 5 , 6, 7 or 8 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

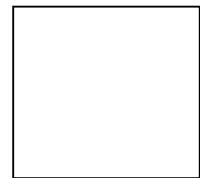
- 18.1 Boats shall be kept in their assigned places in the harbour.

## 21 DATA PROTECTION

- 21.1 By participating in this event, competitors automatically grant to the organizing authority and the event sponsors the right, in perpetuity, to make, use, and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.



## 22 RISK STATEMENT

- 22.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. **Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.**
- 22.2 The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

## 23 INSURANCE

- 23.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of Euro 1.500.000 or the equivalent per incident.

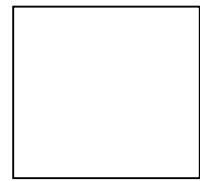
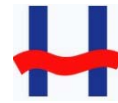
- 24.1 For all Classes: The WSV Hoorn supplies prizes as followed:

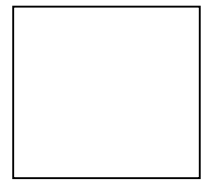
